Circuit of the Northwest Continues the Next Stages of Development

BREMERTON, Wash. (November 1, 2021) – Following a successful ceremonial groundbreaking on October 19, 2020, the Circuit of the Northwest now enters the next phase in bringing a world-class racing destination and motorsports facility to the Pacific Northwest. Under the guidance and care of the Port of Bremerton, clearing work was completed November 23, 2021, to highlight the natural contours of the land featured in the racetrack design. Construction of the 232-acre, multi-use facility and 2.34-mile, multi-use circuit continues and is expected to be completed by 2023.

"The Circuit of the Northwest will put the Pacific Northwest on the map as a world-class racing destination, delivering an unparalleled member experience for the region," said Brian Nilsen, local business owner and founder of the Circuit of the Northwest. "The overwhelming support that we've received for this project has been incredible so far. We are thrilled to be at this point in the development process of transforming the site."

Unlike many racing destinations across the U.S., the design of the Circuit of the Northwest embraces the natural terrain of the area, providing challenging turns and up to 80 feet of elevation changes, coupled with an unparalleled view of the Olympic Mountain Range. The careful attention to the clearing process is necessary to ensure a soft footprint on the land to prepare for final design work by renowned racecourse designer Hermann Tilke.

When complete, the new multi-use facility will feature:

- Two Concert Venues
- An indoor (225 seat) / outdoor (4000 hillside seating) theater
- Skills and EVOC center
- Motocross
- Karting facility
- RV Park
- Festival and event sites for public and private use
- A state-of-the-art 28,000 sq ft clubhouse overlooking the Olympic Mountain Range
- · Restaurant and Bar
- Business Meeting Area
- Gathering Area with outdoor seating to socialize and relax
- Wellness Center

Circuit of the Northwest will also deliver a best-in-class hospitality venue and unparalleled clubhouse amenities that include dining facilities, meeting spaces, simulators, and a wellness center. The destination will also be home to an automobile and motorcycle driving club that will provide ongoing access to the circuit and its amenities for its members.

Circuit of the Northwest in December of 2017 retained the Joel Cohen Group LLC for ownership representation, management consulting, track design and construction of the facility.

"We are proud to support the development plans for the Circuit of the Northwest in such a picturesque location with natural beauty," said Ralph Morton, former executive director of the Seattle Sports Commission.
